Administrator/Clerk report

Ms. Ziemba has Integrated Network Concepts scheduled for the April 30 meeting. They are going to send her an outline of what they are going to go over. She will be inviting everybody throughout the County. Family Life Counseling is scheduled for April 30 as well.

Commissioner Hintz report

Mr. Hintz had nothing to report.

Commissioner Boose report

Mr. Boose asked Mr. Wilde to explain the extra coverage options from CORSA. Mr. Wilde said that CORSA has added some "Program Enhancements". This includes coverage on drones at no additional charge. Mr. Boose noted that Huron County does not have any drones. Mr. Wilde said they were also offering Schedule I and II Substance Control – up to \$35,000 for expenses. Finally, Mr. Wilde noted that CORSA will provide additional Land Bank coverage. They had not discussed the details of this coverage. Since this is something that Huron County is interested in, Ms. Ziemba contacted Mr. Brown. He will obtain more information.

At 9:30 a.m. <u>Tacy Bond, 9-1-1 Coordinator</u>. Ms. Bond stated they are purchasing replacement CAD servers for the 911 and consolidated dispatch system.

She said the Data Processing Board had asked about the extended warranty costs for the servers. She was told the numbers fluctuate so it is tough to get an accurate quote, but it didn't appear to be terribly expensive. She was informed Dell Storage is usually \$2,000 per year; Dell Servers are \$300 - 400 per year. She explained Synology, which is similar to a storage bank, does not have an extended warranty but does have lifetime technical support. This is a small add on charge. She guessed they were looking at around \$2,500 - 3,000 per year. Ms. Bond said this was for after the initial three year warranty period. Mr. Wilde clarified she was estimating the servers would last 6 to 7 years and we would need the extended warranty for years 4, 5 and 6.

Ms. Bond went on to explain the server purchase would consist be three annual payments of approximately \$51,886.36 with a \$1 buyout. Mr. Strickler had reviewed the contract, which he mentioned was a financing contract, not a contact for the servers. He asked if there was any reason we could not buy direct from Dell. Ms. Bond explained they would be purchased through SHI, which is the company their IT vendor uses. Mr. Wilde asked her to explain how we cut them out. Ms. Bond said the IT team that usually take care of their purchasing cut themselves out of the deal and let her go directly to the vendor. This saved the County about \$10,000. Ms. Bond also explained they chose to finance because it is a little easier to spread it out over three years than coming up with the full \$145,000. She said their account is sitting at about \$153,000. She said she has spent almost nothing this year, other than the monthly bandwidth bill. The money is available for them to move forward. She indicated it will take six to eight weeks for them to configure and build the servers. From there the CAD vendor will have to install the software, which will take additional time. Mr. Boose asked if this was State purchasing. Ms. Bond said it was. Mr. Wilde thought the \$10,000 being saved would cover the maintenance agreement for years 4, 5 and 6. He appreciated the IT vendor for allowing that to happen.

Ms. Bond provided more information about the consolidated dispatch system. It consists of Bellevue, Huron County, Willard, Norwalk, North Central. She explained all the equipment is currently housed at the Frontier building, where it is centrally located and routed through networking to all those agencies. She said with this re-design they were thinking about moving it to the EMA building, which will cut it from five legs to four. There are some things that need to be looked at before that could be done, including: 1) the generator at EMA building; and 2) the amperage would need to be upgraded to 200 amp.

Ms. Bond further explained they are currently trying to decide if they should continue with the Frontier lease for 2 more years. She talked to AT&T recently and they are doing a big push for FirstNet. She questioned why they haven't started providing 9-1-1 service, which could be an alternate to Frontier. The rep indicated he was "pretty sure" they could give her fiber. He said the fiber Frontier would run is AT&T's fiber, it is their network. She is working on getting a quote - if that is the case she would prefer to switch.

Ms. Bond said once they get the servers ordered they will sit down and decide if they want to move them to EMA or if they should wait two years. Mr. Wilde said his thought was, if we have a 9-1-1 Coordinator, it did not make sense to have the equipment up at Frontier where we know there have been issues. Ms.

Bond explained they pay about \$2,600 a year to lease the space, that includes the electric and generators. A move would give them more building control. She likes the idea of cutting down the leg - right now everything has to run through Frontier. At their building they have a direct fiber connection with the Sheriff's Department, which cuts down one leg of it. It will also save \$400/month. However, they will have to upgrade bandwidth speed, so costs will go up because bandwidth costs are more. The same will happen if they move the system out to EMA. They will have to increase the bandwidth and go to fiber, which will increase bandwidth costs from \$2,600 a month to \$3,900 a month. This is why she would like to see what AT&T can offer; if it is not cheaper maybe it will be faster. Frontier has only offered 30 meg; she gets 400 at her house. Mr. Wilde asked about Spectrum. She said Spectrum can't offer 9-1-1 service because they have system outages.

The Board gave Ms. Bond a verbal okay on the purchase; they will do the formal Resolution on Tuesday, April 23, 2019.

Ms. Bond also mentioned that she had talked to Everbridge regarding the tornado warning. Their answer was that they only notified the addresses in the affected zone. That was determined by the National Weather Service.

Commissioner Boose report continued

Mr. Boose met with Roxanne Sandles about vacating an area of the building. They asked for space in the old veteran's side of the building. Mr. Minor will go over and work with her to figure out the most cost effective solution. They have a board meeting tonight that Mr. Boose plans to attend.

Mr. Boose asked how the Board should respond to the gentleman (Mr. Hite) here on Tuesday. He asked if they even have authority to address his concerns regarding the Prospect/Fitchville River Road project. Everyone agreed this is the Engineer's responsibility, it is paid out of his funds. Mr. Boose thought if we respond, we should thank him for coming in and tell him we are forwarding his concerns to the Engineer' office. Explain to him the Engineer is the one who has the authority to maintain and take care of the County roads. Also let him know we have asked the Engineer to address the other safety issues and intersections he brought up.
