Updated the board on their process and some of the difficulties they are having with the tool. Heidelberg is working to make adjustments to the tool to make it usable for their purpose. Mr. Stang explained Old Woman Creek's watershed is 25% in Huron County. Received a mini grant from ODA and state federation for an augmented reality sandbox with projector above it, this is all 3D. Mr. Stang explained he has \$1,000.00 coming from the State and he reached out to all the local schools. Some replied and some didn't, Mr. Stang explained that they will train a couple of teachers to use it.

Mr. Stang explained the Walmart grant for trees, as an educational tool. Mr. Stang stated that 2017 will continue to have the building renovations and paving their parking lots.

Mr. Boose explained his conference call, he is currently on the CCAO Taxation and Finance committee in regards to some tax and finance issues moving fast in Columbus, some of them the Board already knows about, the Medicate Managed Care replacement we know that we are only getting some money back at a one time basis. Mr. Boose stated that 44 out of the 88 counties are going to get less than the one year amount. Mr. Boose stated that Huron County probably will not get the one year amount. Ms. Boose explained that 16 counties are going to get 2 years or more worth of this money. Mr. Boose stated that Huron County is not one of those counties. Mr. Hintz asked how they rate this, Mr. Boose explained the Governor has a formula.

Mr. Boose explained that the Governor tried with the three previous budgets tried to increase the severance tax on oil and gas. Mr. Boose explained that severance tax is if you're pulling an asset out of the community its being taxed. The tax on oil and gas is around 3%. The issue is where these companies are going to go, it depends on the taxes. The issue is that Ohio has the lowest oil and gas tax, however we have taxes other states don't have. The Governor wants to raise this to 6 %, there for we would not be in the ball park. Mr. Wilde asked where this 3% goes, Mr. Boose stated it use to go into the general fund. This week Governor called CCAO into his office and explained that he is tired of fighting over this local money. The Governor suggested taking the increase and severance tax and give it to you, your local government fund. Mr. Boose stated this is pitting your local governments against the state that is making economic development decisions, where Mr. Boose stated no and CCAO is in agreement to oppose this. Mr. Boose explained that they are thinking about putting an amendment into the budget to allow Commissioners to add \$5 to the license plate tax. As of right now townships, cities and counties can but there is a limit, this will increase the limit to what you can do. Mr. Boose explained the sticky situation in regards to this is, the current amendment states they can do it without a vote however it can be referendum. There are 2 ways this \$5 can be added one:

1. Commissioners can just added

2. Petition process

3. By vote – Issue with this is under the current system in Ohio people never voted to increase taxes. This is really hard as a Commissioner to say take it to the people to vote, if it's never been approved why go through the process. Mr. Boose asked what could this money be used for, Mr. Strickler stated it is for roads.

#### • Budget

Mr. Boose explained there are sign-up sheets being passed around to schedule for budget hearings. Hearings will be Tuesday Feb. 21<sup>st</sup> and 28<sup>th</sup>. If these days don't work contact Ms. Ziemba and she can schedule.

Mr. Boose explained what he means by a sustainable budget

Mr. Boose explained the Medicare tax the counties are losing and how it affects Huron County. Mr. Boose explained how the breakup of local government funds of 1.66% are broken up. Mr. Tkach explained the breakdown.

Additional tax is more for the Engineer.

Mr. Wilde explained their thoughts behind creating a "Revenue Enhancement Officer" to help seek grants for the county, townships, villages, etc. Mr. Boose explained further why the name is not a grant writer. Discussed whether the county needed to continue with the "requests for expenditures over \$1,000.00". Mr. Boose stated there may be changes in the future.

## • Conceal carry (Senate Bill 199)

Mr. Hintz and Mr. Boose stated that the board is planning to allow the conceal carry in all building except those exempted by law. Looking for feedback for or against. Ms. Schaffer stated she is against it due to the amount of money they deal with in the Treasurer's office. Mr. Welch asked if the employees could carry as well. Mr. Wilde stated he would like the prosecutor opinion.

Mr. Hollinger stated his concern is we have no control of their employee's emotional state on each date. Further discussion was had amongst the attendees. Mr. Boose stated they are looking

for anything unique that would cause them to go against what the new law indicates. Discussion of whether it can be in a building that houses federal employees.

Judge Conway explained that he invites every felon into town to go into the adjoining building (Office Building) so there could be concern.

Mr. Boose asked for any comments to be put in writing and sent the Commissioners by March  $1^{st}$ .

## • Records retention & storage

Mr. Hintz explained the commissioners are looking at using the basement in the antique mall building. Mr. Boose stated there will be rules and procedures when doing this and will need everyone's cooperation. Mr. Wilde explained his concerns for the current storage areas. Jan Tkach stated most departments have a records retention schedule but there are some that are required to be kept permanently.

## • Building maintenance – Long term plans

Mr. Wilde explained they are interested in doing a five and ten year plan. Would like the departments to express any needs they may have in their office so it can be added to the plan. Requests these be brought to their budget hearing.

Discussion about the old jail.

Discussion of parking lots. Mr. Welch stated the engineer is reviewing our parking lots and putting together costs. These will be put on a schedule for replacement. Discussed changing the makeup of the parking area behind the Office Building.

Mr. Boose stated this is not just for buildings but for equipment and any capital improvements. Roxanne Sandles asked if there is a plan for the Shady Lane Building. Mr. Wilde stated they would like to take it down once those occupants have found new space. Does not intend to kick anyone out. Mr. Boose stated they would like to tear it down in about a two year timeframe. Ms. Hazel explained the leak at the courthouse.

## • Open discussion

• Any topics departments wish to discuss

Mr. Wilde stated he would like to continue to have these types of meetings to update the departments. Ms. Tkach request the doors not be opened before 8:00 a.m. for security reasons.

At 1:06 p.m. Bruce Wilde moved to adjourn. Terry Boose seconded the motion. The meeting stood adjourned.
