The Board of Huron County Commissioners met this date in Special Session. Roll being called found the following members present: Terry Boose, Joe Hintz, Bruce Wilde.

At 2:30 p.m. the meeting called to order.

Mr. Boose stated that because there may be an issue regarding the public hearing for the Stieber-Metro Parks Ditch petition on Tuesday, December 4, 2018, due to the fact we may not have a quorum we will not be able to have the meeting and a notice needs to go out ahead of time. The Stieber- Metro Parks Ditch petition first public hearing need to be cancelled.

Joe Hintz moved to cancel the Stieber-Metro Parks Ditch petition first public hearing. Bruce Wilde seconded the motion. The roll being called upon its adoption, the vote resulted as follows:

BE IT RESOLVED, that the foregoing resolution was adopted and all actions and deliberations of the Board of Commissioners of the County of Huron, Ohio, relating thereto were conducted in meetings open to the public, in compliance with all applicable legal requirements, including Section 121.22 of the Ohio Revised Code.
