Mr. Boose said it had been a year ago. Everybody agreed it was a good idea, as long as they would continue to use who they want, when they want. Mr. Tansey said the Engineer's office is 100% on board and does not necessarily want any control. Mr. Boose thought it might be a good idea to have Sandusky County come in and explain to our elected officials what had happened to them. He thought there were some lessons to be learned and everybody should not have to worry about their own cybersecurity. He believes we can do better as a whole. **BE IT RESOLVED,** that the County Engineer is authorized by this Board of County Commissioners to use such county employees and property, lease such implements and tools, and purchase such materials as are necessary in the construction, reconstruction, improvement, of bridges and culverts by force account. And that, when determining whether such construction, reconstruction, improvement of bridges or culverts may be undertaken by force account, the County Engineer shall first cause to be made an estimate of the cost of such work using the force account project assessment form. When the total estimated cost of the work exceeds one hundred thousand dollars, this Board of County Commissioners shall invite and receive competitive bids for furnishing all the labor, materials, and equipment necessary to complete the work, in accordance with sections 307.86 to 307.92 of the Revised Code. WHEREAS, Mr. Welch has obtained a quotes from:

• Monroeville Freightliner, Inc. \$141,663.00;

Bruce Wilde seconded the motion.

\*Discussion: Mr. Boose noted this was also being paid for from the recycling grant. Ms. Ziemba said the money from the recycling grant was paid into 525 and \$100,000 will go toward this vehicle. The trade-in is estimated to be between \$40,000 and \$45,000 – that is their match.

The roll being called upon its adoption, the vote resulted as follows:

At 9:59 a.m. the board recessed.

At 10:11 a.m. the board resumed regular session with Senator Manning, Representative Stein, Sheriff Corbin, and Chief Deputy Ditz to discuss the issues with receiving the 2019 law enforcement vehicles. Mr. Boose said they had asked Mr. Stein and Mr. Manning to come in because, despite the Sheriff's efforts, we still have not received the new cruisers that were ordered last year. Sheriff Corbin explained the cruisers had been ordered last February through State Purchasing. The dealer is in Lebanon, Ohio. They have had problems in the past with orders taking a long time, but nothing to this extent. Mr. Boose said they had contacted CCAO for suggestions. John Leutz looked into the situation and indicated it would be another month. However, they still have not received the cruisers. Mr. Boose does not want State Purchasing to give us dates. He thinks it is time something needs to be done. We seem to be at the mercy of Ford. Mr. Stein asked if Ford was the only option. Sheriff Corbin explained we can pick the brand, but his research has shown Ford Explorers are the most cost effective. They can purchase them fully equipped for \$36,000. The only thing he has to add is the striping and a radio. A Chevy Tahoe runs \$42,000 and requires an additional \$5,000 in equipment. Lebanon Ford won the bid for three years. They have always been told delivery would be 120 days after the date of the order; they are well past that. Sheriff Corbin called and talked to Frank Beaver at Lebanon Ford. Mr. Beaver explained the problem went back to Ford. Due to layoffs, Ford skipped the 2019 production and went right to 2020. Mr. Beaver told the Sheriff there was nothing he could do. Sheriff Corbin is now checking into the Dodge Durango, which is coming out with a pursuit SUV. There was discussion regarding different types of vehicles and pricing. Being a rural county, SUVs work best. Sheriff Corbin has talked to Ken Ganley and is in the process of getting a Durango to demo. He explained they are now 4 vehicles behind and are looking at having to purchase 8 vehicles this year.

Mr. Boose pointed out that another issue with changing brands is that we have our own mechanic. He has Ford parts in house. If we switch vehicles, this would be another expense. Senator Manning indicated he had spoken to one of the directors at Ford. The only thing he learned was that this is a U.S. wide problem - they are really struggling with demand. The director was going to try to get him a hard date as to when they would be caught up. Mr. Hintz pointed out these vehicles were ordered 2019. Since it is now 2020, he wondered if we were still getting 2019s. The Sheriff said they were supposed to be the 2020 production year. Mr. Wilde asked if they were the same price. Everyone thought the pricing should be honored.

Mr. Boose said it has always taken time to get new cruisers. Mr. Strickler said there has always been a 4-6 month wait period. Mr. Boose did not think that was acceptable either. We are replacing the cruisers for safety reasons. We are adding a whole year of use to a vehicle and we are really pushing that life. Mr. Stein asked how many miles are put on a vehicle in 5 years. Sheriff Corbin said the worst one is at 210,000. He noted that every Sheriff's office in the State of Ohio orders from Ford. He thought that, knowing this, Ford should produce a set number each year. Mr. Stein asked if the packages were all the same. The Sheriff said for the most part they were. With the State bid pricing, they set a standard.

Mr. Manning asked the Sheriff if any of his colleagues had indicated problems with other brands. Sheriff Corbin said this would be the first run of the new pursuit package on the Dodge Durango. He has already been making phone calls trying to get ahead of it. There is a concern right now about having enough vehicles. If something were to happen, say a deer runs out in front of one of them, they will be short. Mr. Boose thought that was a good point. Sheriff Corbin agreed, saying just one accident could change the dynamics of how they operate. He explained Monroeville was going through this right now. They had two cruisers go down and are using one of the Norwalk PD vehicles. There was discussion about canceling the Ford order and just ordering 8 Durangos. Mr. Stein asked about the cost of the Durangos. Sheriff Corbin explained the state bid pricing has not come out on this package yet. But from the information he has, he believes it will be comparable. Ms. Ziemba said they would not able to order Durangos in place of the Explorers. The money had been earmarked for Ford last year. They cannot use 2019 money for 2020 orders. She thought they could cancel the order and ask the Budget Commission to put that money into 2020, but that would just complicate things further. The Sheriff was hoping that, since this is the first production year for the Durango, their pricing would be cheaper than the Explorer to put some pressure on Ford. Mr. Manning pointed out that part of the problem was lack of competition – most of the agencies he knows use Ford.

Mr. Boose also wanted to discuss the jail capital budget request. He thought it may be time to start a discussion about adding on to the jail. Sheriff Corbin said he had explained the situation to Mr. Stein and Mr. Manning with the TCAP funds, working with the judges, and the law change for 4<sup>th</sup> and 5<sup>th</sup> degree felonies being housed in the local facilities. At some point you hit a bottleneck, and they are at that juncture where there is not a lot of room. The jail is a 136-bed facility. Today they are at 147 inmates. Mr. Boose noted that when they pushed the limits in the mid-90s there were findings and orders against the County. Sheriff Corbin said he was asking the Judges to help find other ways, whether it be to furlough them, release them on bond, ankle monitoring devices, or half way houses – anything to keep them out of the County jail. Mr. Boose noted the jail was about 22 years old and we have done quite a few projects in the last few years. It is at that age where things start wearing out. The Sheriff said the roof is the biggest thing they are dealing with now. Chief Deputy Ditz said they have also submitted for a grant through CCAO. Mr. Stein indicated he had a copy and will follow up.

Mr. Boose wanted to make Mr. Manning aware of the discussion earlier regarding the fuel tax that had been passed last year. He said the County Engineer was able to do an extra \$1.5 million in road construction and resurfacing projects because of it. Mr. Boose knew it was not an easy process, but the County appreciates it. Mr. Stein said it is not always easy to get people to realize there is a positive local benefit to these things.

At 10:45 a.m. the board recessed.

At 11:20 a.m. the board resumed regular session.

#### **Administrator/Clerk Report**

MOU regarding the acceptance and calibration of equipment provided by the Ohio Department of Public Safety. Mr. Strickler explained local fire departments have had radiation detectors for years and they are very outdated. The State is giving four to the County. Mr. Mead will pass out to the local fire departments and keep one.

Budget Commission meeting minutes from January 2. They will be meeting again on January 15 at 10:30 to review the General Fund estimated revenue. Mr. Boose would like Ms. Ziemba to attend this meeting if she is available.

Ms. Ziemba mentioned the letter from the Chamber of Commerce regarding the reformatted membership structure. The membership rate has gone from \$150 to \$300. Mr. Boose felt we need to renew it. We do this for the Safety Council. He suggested Ms. Ziemba call and verify this fee amount covered Safety Council.

The State sent a form to see if the County planned to keep the bee inspector. Discussion whether the contract should pay for equipment. Mr. Boose would like to offer the same contract and see where it goes.

Ms. Armstrong has asked if we would like to offer CPR training this year. We cannot use grant money or wellness money. Mr. Boose thought we should offer a CPR course every other year, with QPR on the opposite years. Ms. Ziemba said QPR was set for this year. It was decided to wait until next year for CPR. QPR can be paid for with wellness money.

Schindler Elevator. We have received a final request for payment. Mr. Welch is going to email them to let them know we received it. However, they have not completed everything on the contract. Mr. Welch will tell them they need to finish these items and also come into the office and talk to us.

Mr. Armstrong has already begun work on combining the three rooms in the basement for the Board of Elections. Mr. Boose told them to take down the shelf the old security system was on. Mr. Minor thinks he can use it for the new system.

All the Commissioner's records have been moved from 22 E. Main over to the Administration building.

When the new security system is in we will get two new exit lights to replace the two downstairs that are not working properly.

They are still waiting on a report from Mr. Smith on the generators. None of the three generators was a backup for the Board of Elections.

The top part of the Health Department sign should be removed by the end of the month, but they will wait until the weather is better to remove the rest. All the generators are supposed to be gone by the end of the month as well.
