

The Board of Huron County Commissioners met this date in Regular Session. Roll being called found the following members present: Terry Boose, Joe Hintz, Bruce Wilde.

**At 9:00 a.m. Terry Boose moved to enter into Executive Session ORC 121.22(G)(6): details relative to the security arrangements and emergency response protocols for a public body or a public office, if disclosure of the matters discussed could reasonably be expected to jeopardize the security of the public body or public office relative to Governor DeWine’s Executive Order 2020-01D, issued on March 9, 2020. **\*Action taken:** *Mr. Boose stated we are in a very fluid time right now. We are looking at all our departments to try to reduce staff. The intention is to put staff on paid administrative leave. Therefore, they can be called back at any time if we need them.*

Mr. Boose had a question for Mr. Strickler. The email from CCAO said the Commissioners can only control those who are underneath them. Mr. Boose asked what authority the Commissioners had over someone like the Public Defender’s office. They are appointed, not elected. But they are in a building owned by the Commissioners. Mr. Boose asked if they could just tell the Public Defender the building is closed and no one is allowed in? Mr. Strickler said the problem is the Courts are continuing to go on. Lawyers and legal services are essential services under the Governor’s memo. Mr. Boose said every time he stops in the staff is asking if they can go home and looking to him for guidance. Mr. Strickler thought he should tell Mr. Longo what they are doing and let Mr. Longo make that decision. Similar to an elected official, he is a department head. Mr. Boose will stop in and talk to Mr. Longo.

Mr. Boose informed Mr. Hintz that John Chime’s son is working for the County through the FYR program at Job & Family Services. Because he knows a little about electronics, Mr. Boose has asked him to set up a Facebook page for the County. It is for information only – no one can leave comments.

**At 10:26 a.m.** Bruce Wilde moved to adjourn. Terry Boose seconded the motion. The meeting stood adjourned.
