The Veteran's came before the Board in regards to the Veteran's office building needs. Matt Raymond, Director of the Veterans Services stated that they have been asked to move their operations from their current location at 130 Shady Lane Dr. Mr. Bauer questioned who asked them to move. Mr. Raymond stated it was the County Commissioners. Mr. Bauer stated no, we didn't. Mr. Dunlap question who would have told them that, and Mr. Bauer stated this is a total shock to him. Mr. Raymond stated that was his fault, he apologizes. Mr. Raymond stated that the state of the current building is in need of repair. They have put over 2 million back into the General Fund since 2006 of their allocated funds. Mr. Raymond explained that they currently have plans drawn to have a building constructed in cooperation with the Senior Enrichment Services. Mr. Raymond stated they have an architect that agrees with the site they have chosen for this new building. Mr. Raymond stated they do have other options to move to if the site is not approved. Mr. Dunlap questioned where the architect thinks is a good fit. Mr. Raymond stated that the place they had proposed with cooperation with Senior Enrichment Services which would be on Shady Lane Drive next to the new License Bureau. Mr. Bauer stated the Board of Commissioners is waiting for Veteran's Services to get them a proposed plan, because they are their own board. Mr. Bauer questioned if they ever got a ruling from Ms. Kasper regarding on how to use the money. Mr. Raymond explained that he did receive a legal opinion from Ms. Kasper that the Veteran's Services cannot sell bonds to fund the construction of a new building. Does do have the power to issue or sell bonds itself. Huron County through the Board of Commissioners is empowered to enter into agreement for the sale of bonds with the commission such as Huron County Veteran's Service Commission. Mr. Raymond stated the other question was if the sale of the bonds can be funded in the construction of a new building. Mr. Raymond stated Ms. Kasper's legal opinion was that the Veterans Services could not sell bonds for any reason, but in cooperation with the Board of County Commissioners, Veterans Services could accomplish that.

Mr. Bauer questioned if they received a ruling if the \$527,000.00 could be used. Mr. Raymond stated they have not. Mr. Bauer stated that they need a ruling from Ms. Kasper to see if they could use this money to pay back the bonds. Mr. Dunlap stated that theatrically the Veterans could get bonds for a new building, get it constructed and earmarked \$200,000.00 of the \$527,000.00 back to the Commissioners to pay the bonds every year if it was legal. Mr. Bauer stated that they need to know from the Prosecutor if they can use part of the \$527,000.00 to pay back bonds.

Mr. Brown discussed cyber insurance, he stated that he sent an email to the Commissioners regarding this issue. He would have to sit down with each vendor and go through what they offer in cyber insurance, but doing so without a central IT division is work that doesn't make sense. We do have cyber insurance, however it is enough, and Mr. Brown doesn't know the answer to this.

Mr. Brown explained by January 31, 2016 we need to produce a 1094 & 1095 Form to the IRS, this is both related to the Affordable Care Act and IRS reporting standard. Mr. Brown has contact the entity who will be doing this in 2016 to see if they will be able to help with 2015. Mr. Brown stated they have the resources however it is going to cost us some money, roughly \$2,000.00. Mr. Brown stated that with the proper data, which will be hard to gleam, although the Auditor's system should give us some information and MMO software maybe able to also give us some information. If MMO software cannot, we will need to generate this information on our own. Mr. Dunlap asked if they could use the Trust Fund to pay for CEBCO. Mr. Bauer stated he doesn't know that answer to that. Mr. Brown stated they will not be able to contact this whole job out do to the information needed. Mr. Bauer asked Mr. Brown to contact Ms. Kasper to see if the Trust Fund can be used.

Mr. Brown discussed the possibility of keeping all the bureau of Worker's Comp. money in a pool payable from the Commissioners budget. Mr. Brown stated he can track the departments internally, the process to paying the Worker's Comp bill to have a line item for hospitalization to everyone's budget. Mr. Brown read a memo from the Auditor's office, the purpose of keeping the BWC money in one pot would allow for accurate billing for all departments. Since the first payment is due January 2, 2016, it will decrease the amount of time billing back to the departments. Ms. Ziemba stated this will delay the budget if they want to change this for FY15.

Mr. Brown questioned if the hospitalization is a line item for each department. Ms. Nolan stated she thought there was already one, but looking through the budget it was deemed there was not. Mr. Bauer stated that if push comes to shove they could make a change, send the budget sheets out today. Mr. Brown will get additional information from the Auditor's office and will get back with the Commissioners.
