Administrator/Clerk's Report

Cheryl Nolan stated that she had received a call from Carol Denison a resident who was having problems with internet service at her residence. Ms. Nolan stated that she has contacted Huron Economic Development Director as Ms. Denison had learned that Medina County had a grant for wireless internet services for their entire county. Ms. Knapp is looking into this. Mr. Bauer stated that after learning of this situation he had also contacted Steve Euton, Frontier to see what he could do to help with this situation as well.

Ms. Nolan stated that she had received a call from VASU Communications stating that they were having an open house at their facility on October 24, 2012.

At 9:30 a.m. Public Comment

Sheriff Howard explained the 9-1-1 system failure again twice in three and a half months and stated that he still hasn't received a clear cut conformation as to what happened to cause this. The problem is that we have multi vendors to deal with and in both circumstances there has been finger pointing as to whose responsible. We need to figure out who that body would be. Sheriff stated that he is not trying to say anything against any particular business but from there prospective having one vendor to handle this means

that we can narrow it down very rapidly and get service back to our community in the fastest time that we can which is a primary focus for all of us. The sheriff stated that he is here today to ask the board to make some changes in our system. Jason Roblin, EMA Director stated that there is one point of failure for the 9-1-1 system and it happens to be the same success or failure for the phone system and stated what can we do to make it more redundant and further stated that he knows we are going to the fiber optic system but wonders how redundant that will be or are there other options that we should be looking at to make the systems more resilient. Steve Euton, Frontier stated that in summary there was a commercial power failure in that area which was very brief and during this failure the line for the 9-1-1 system did not handle the power failure that well and they immediately responded after a phone call from the sheriff's department. Once they arrived they determined that it was above and beyond the 9-1-1 system it was the support device and they could immediately trouble shoot it getting it back on line. The event that occurred should not have happened as the system does have backup etc. Further discussion was had in regards to the procedures used by Frontier and Ohio Telecom. Mr. Euton stated that they only received word from the sheriff's department not from Ohio Telecom. Ohio Telecom technical advisor stated that everything on their network is monitored and further explained and presented Huron County Shady Lane Outage.txt log and further explained how they knew it had to be a Frontier issue with those circuits. This discussion back and forth continued. At this point Gary Bauer stated that we are here today to find out what can be done so that this does not happen again. Different options were discussed. The sheriff spoke to his issue once again with having two vendors and further stated that two hours without 9-1-1 system working is a long time and further explained that they received many calls in that time frame and that they also get a lot of emergency calls that come in on the regular phone lines as well and that they were dead. The sheriff stated that thank goodness no emergencies happened. Mr. Euton stated that when this system failed all calls were routed to Norwalk Police Department and no calls were dropped the alternative backup kicked in right away. Mr. Roblin agreed that no 9-1-1 calls were dropped. Mr. Silcox stated that he agrees with the Sheriff that two hours for the 9-1-1 system to be down is unacceptable and further stated to Mr. Euton that he agrees that the equipment failed when it shouldn't have but they are taking steps to correct that. Mr. Euton stated yes. Mr. Silcox stated that this is the second time since August. Mr. Roblin stated that he would ask that when departments have an outage or a surge the call the electric company because when he calls Mr. Mortis from the electric company he will say you are the only one that has reported an outage or you are the only customer that has a problem. Mr. Silcox stated or asked working with both of you how can it be built to get to where we need to be where we have more than one access to the equipment. It was suggested looking at going the other way down Norwood as the Norwalk High School now has a path to Norwood. Mr. Silcox stated that he would like to see us have a second path and a third option of fiber optics. Mr. Silcox stated that he thinks it is imperative to have these options and how do we get to this. Mr. Euton stated that they have a meeting set just for this purpose. Mr. Silcox asked that we not go in the same direction with fiber optics as now. It was stated that yes that if the fiber had replaced the current system last week when that outage occurred the phone lines would not have gone down. Mr. Silcox stated so you are telling us by the end of next week it will be in place. It was stated that assuming that there are no issues that we would have to re-pull it. Discussion was further had in regards to this happening again when the change over is made. Mr. Silcox asked Mr. Euton to present a report on their equipment and what happened. The sheriff asked for notice when this change over takes place so that he can notify the Norwalk Police department so that they can prepare for it the best that they can.

Mr. Bauer stated that he thinks the sheriff would rather have a bird in the hands rather than a promise of 3 birds in the hands that may not happen. Mr. Silcox stated but if he gets this one then he only gets 2 new cruisers if funds are available. Mr. Silcox will talk to Mr. Ousley and find out the particulars in this regard.
