#### **OLD BUSINESS**

Cook Road. Ms. Ziemba said the last notes she had indicated they had until April 1.

Old jail. Mr. Stephens stated he had reviewed the documents. Discussion regarding the lot split process. Mr. Stephens suggested they may want to consider registering the entire block as a historical district. Ms. Ziemba was concerned this may hinder any repairs to the building, particularly 22 E. Main. Mr. Boose pointed out they had time to think about it.

Architect for roofs. They will be signing the resolution today.

Meeting Room A. Ms. Ziemba was aware the one door had been ordered. She has not heard anything regarding the soundproofing. Mr. Boose thought they had decided to wait on that until the door came in.

Deferred comp Roth option. Mr. Boose thought they should follow up with Auditor Tkach to see where things stood.

The last thing Ms. Ziemba had was Sheriff's vehicles, which had been done today. Mr. Boose was concerned. He thought they were buying three cars and only getting rid of the two Chargers. The agreement had always been when the County buys new cars for the Sheriff for the road that he get rid of an equal number of cars. Ms. Ziemba will follow up.

#### **NEW BUSINESS**

CHIP HAC Meeting. Mr. Hintz stated he had tried to get in and had been unable. Mr. Boose said this was all the more reason not to do electronic meetings anymore. There is always a problem.

Mr. Boose said the Statehouse report indicated the Senate passed out the transportation budget with some changes. However, increasing the Force account amounts was not part of what they passed. They did pass something for a joint committee on Force accounts.

Mr. Boose asked if the County now had a TID and a committee. Mr. Wilde said they did, they passed all that. Mr. Boose said ODOT received an annual appropriation of \$4.5 million for transportation improvement districts. They may not award more than \$500,000 to any one TID in one fiscal year. The budget covers two fiscal years so Mr. Boose thought some could get up to \$1M in a year.

Mr. Boose said they just announced the TCAP grant last week and the County was already applying for it.

Records Retention meeting last Thursday, it went well. Had four different RC-2 that they approved. A couple of them were in regard to Coronavirus Relief Fund records.

WIOA Board meeting last Wednesday. Still a lot of work to do on workforce development-type issues.

#### TUESDAY

9-1-1 Committee meeting, followed by a 9-1-1 Planning Committee meeting. At the Planning Committee meeting Ms. Bond mentioned they currently have three licenses for radio frequencies and she would like a fourth. Mr. Boose suggested Ms. Bond come in to provide an explanation.

After the meeting Mr. Boose spoke to Representative Stein, who had a lot of questions. Mr. Boose suggested he talk to Ms. Bond. Mr. Boose would like a meeting set up with Representative Stein and Frontier. Things keep getting extended because they say they are going to fix it. They have been saying that for two years now. Mr. Boose felt there needs to be a meeting and a plan.

Ms. Cardone had sent Mr. Boose the March 22, 2021 MHAS Board report. The Quick Response Team community data from February and March indicated there were 15 overdoses, with 10 fatalities. That was extremely high for two months. Mr. Wilde noted you don't hear about this. Also, MHAS staff is looking at recovery housing and has toured multiple locations. They will be meeting with Norwalk City Council on March 30.

Firelands Forward had a Board training meeting last Thursday and will hold another one this Thursday. At one time Firelands Forward was told they could have a desk at the Norwalk Economic Development office. With Ms. Horowitz leaving they want to make sure that was still available.

Airport Cares grant. Ms. Ziemba did not know if the paperwork had ever been updated. The original documents listed Mr. Wilde as the Airport Manager. The Prosecutor reviewed and advised not to sign it until it was corrected. Mr. Boose suggested Mr. Hintz follow up on the status of the documents. With two new Board members he was a little concerned with connecting with them and making sure everything was moving. Ms. Ziemba stated she sent the Wilkes proposal to the Airport Board. She let them know what the Commissioners wanted and that they would cover this as long as the Airport Board covered everything else. The Airport Board said they will definitely move forward on this. They will obtain the necessary additional bids to comply with requirements.

Ms. Ziemba had received an email from Ms. Bond regarding the Ohio Edison bill discussed earlier. This was for one month and was the same cost it had been for the last two months. The one in Willard, through AEP, is averaging \$155/month.

Mr. Stephens provided a general update on the Route 20/601 roundabout. The Department of Transportation had filed their appropriations actions for some of the surrounding land, including where the Gulf Inn sits. They are basically taking the entirety of the frontage. Mr. Stephens said they are not taking the building, but are essentially making the business unable to run. Mr. Boose thought if ODOT was leaving the building they probably have to pay them something. Mr. Stephens said they are being paid \$4,500 for 4/10 of an acre. Mr. Boose said he kind of assumed if they were going that close to building they would be buying the building.

At 10:15 a.m. With no further business to discuss, Bruce Wilde moved to adjourn. Joe Hintz seconded the motioned. The meeting stood adjourned.
