Old Jail. Ms. Ziemba clarified that the deadline had been extended to September 30. She will update her notes.

Snow policy. Ms. Ziemba was going to start working with everybody to get an idea of what they want. She thought Level 3 would be an automatic two-hour delay. After that it was up to each elected official. Also, it was noted that Mr. Welch had discussed bidding out the plowing since Mr. Homan would no longer be doing it.

Health Department fees. Mr. Wilde was waiting to hear from Mr. Cherry.

RUMA. Mr. Strickler had begun his review of the RUMA. When he finishes he will meet with Mr. Tansey and they will set up a conference call with Apex.

Parking Lots. Ms. Ziemba noticed the Sheriff's office and BMV/Title were done. Mr. Wilde thought everything was done and striped.

Roofs. No updates. Waiting on the architect for the change order to extend the deadline.

JFS Carpet. Mr. Boose had been told by Mr. Welch that the documents were given to Mr. Strickler for review. Mr. Strickler will check his office.

Indigent Defense. Mr. Boose said this had been discussed last Thursday in Summit County. They were not looking for big changes; they just want rates set so the State knows what they are. The recoupment plan was something the County should already have, so we will have to come up with one. Ms. Ziemba said the Bar Association was working on the reimbursement because ours had not been updated to current standards.

Veteran Service Commission was hosting a 20th Year of Remembrance Ceremony for 9/11. It will be held on September 11, 2021 at 8:25 a.m. This will be a two-hour ceremony coinciding with the timeline of that day. Audio and visual components will be used.

Network After Work, the NEDC annual celebration of community and businesses, will be held Thursday, October 7th from 5:30 p.m. to 7:30 p.m. at Sandy Ridge Vineyards.

CORSA annual membership meeting will be held on September 10th at 10:00 a.m. Mr. Wilde will be attending in person with H.R. staff. Mr. Brady will be attending Erie Basin in Tiffin that day.

Mr. Brady attended the CEBCO meeting. He thought it was interesting. The rate increase for Huron County will be zero. Some counties had increases of 13%, other counties rates went down.

At 10:00 a.m. <u>Kristen Cardone, MHAS</u>, Suicide and Overdose Fatality Review Committee update. Ms. Cardone discussed this with Tim Hollinger and he was in full support. He suggested doing a joint committee due to the size of the County. Mr. Hollinger was willing to chair, do the minutes and publish reports. His only request was that Ms. Cardone and the Commissioners decide who they want on the committee. Ms. Cardone had a tentative list and made some suggestions. Mr. Boose would like a commissioner to be on the

committee, and volunteered to do it.

Ms. Cardone noted that overdoses were down. However, they usually are this time of year so she said it was nothing to get excited about. Discussion followed regarding addiction and suicides/mental health. Ms. Cardone agreed to provide data to the Board. She also provided an update on the purchase of the Recovery House and passed out information regarding mental health and addiction in the workplace. Discussion followed.

At 10:30 a.m. the board recessed. At 10:40 a.m. the board resumed regular session.

The Board reported on their meeting in Akron last week. Mr. Wilde said that as far as IT, there had been good information. He had a business card from a gentleman in Summit County and would like to physically go to Medina County to talk to them. He will discuss all this with Mr. Riedy.

Mr. Boose asked if we were in the process of looking for an assistant for Mr. Riedy. Ms. Ziemba said they were meeting next Wednesday to discuss the job description and the posting.

Mr. Wilde and Mr. Riedy are scheduled to tour the fairgrounds tomorrow to see what they can do for wifi infrastructure. However, this depends on the availability of ARPA funds.

Meeting in Ashland at 2:30 tomorrow. Also, tomorrow night is the Firefighter's Association in Townsend and the Farm Bureau meeting in Wakeman at 6:30.

Township Dinner will be held on Thursday night at 7:00 p.m.

Friday Mr. Wilde will attend CORSA; Mr. Brady will be in Tiffin.

9/11 ceremony at Veteran's Park on Saturday.

Next Monday Mr. Wilde will attend the Senior Citizen Award ceremony.

Mr. Boose asked about last week's meetings. Mr. Wilde said they had the CORSA meeting in Meeting Room A on Wednesday. It was very good. Talked about a lot of issues and how to avoid them in the workplace.

Thursday was the meeting in Akron. Mr. Boose thought it was nice to have so many CCAO people there to answer questions. Ms. Ziemba asked if they had discussed hosting a meeting to get input. She thought some of the bigger counties were required to do this. Mr. Boose said a couple counties were doing it, but he did not think it was required. CCAO had been surprised by the number of townships and villages that didn't apply for the money. Discussion followed. Mr. Boose noted there were four townships that really should be looking into sewer infrastructure but as of a week ago they hadn't applied for it.

Last week Mr. Brady attended the CORSA training. After that he went and met with Judge Conway. Mr. Brady would like to revisit the subject of the third-floor restroom. Mr. Boose pointed out that they had not been used for a minimum of ten years, if not more. The problem was not the bathroom itself, it was the infrastructure for the bathroom. It had already been studied and restudied. It would be very costly and was not just a simple remodel project.

This week Mr. Brady will go to Erie Basin. Also, HCDC has an Executive Board meeting on Thursday morning. Mr. Boose explained they are only advisory members for the Executive Board, they can't vote.

Monday night Mr. Brady will be at the Huron River Joint Fire District training meeting. Mr. Boose suggested it would be beneficial for him to go to the monthly firefighter meetings held on the second Wednesday of every month. They have had some excellent trainings.

Mr. Brady said he was working on transportation. He had some calls in to some other counties.

Last week Mr. Boose attended a webinar on Senate Bill 52. A very important next step will be the webinar on September 15. That one will be put on by the Ohio Power Siting Board and will discuss the roles of the commissioners and trustees are and how the process would work.

Mr. Boose has a Fireland's Forward meeting tomorrow at 8:30 a.m. It will be held in the Norwalk Economic Development Board room.

Farm Bureau meeting tomorrow night. Mr. Boose will attend.

Thursday is the HCDC meeting at 8:00 a.m.

Thursday evening is the Township Trustee meeting at 7:00 p.m.

Assistant Prosecutor report.

Friday is the deadline to vote on the approval of the Mallinckrodt bankruptcy plan in the opioid suit. Since Mr. Strickler has not received an email yet, he would like the Board to authorize him to approve it in the event their National Council recommends voting for the plan.

Bruce Wilde moved to authorize Randy Strickler to act on behalf of the Board in the event their National Council recommends voting for the Mallinckrodt bankruptcy plan. Harry Brady seconded the motion. The roll being called upon its adoption, the vote resulted as follows:

Mr. Strickler stated that, starting today, the Courthouse was requiring masks.

This was something that was worked out amongst the schools and he did not know why the County was picking up the tab. Mr. Wilde agreed, indicating we can pick it up this time, but we need to get word out that this should not come from the General Fund, it should be through the school's funding. Ms. Ziemba will send a message to Chief Deputy Ditz that it is okay this time, but in the future everything should be paid for by the schools.

Mr. Mead had sent a request to Ms. Ziemba asking to participate in the memorial services for UNS Corpsman Maxton Soviak. Ms. Boose did not think this was a responsibility for Huron County's EMA office. however, if Mr. Mead wanted to use his personal time Mr. Boose did not have a problem with it.

Mr. Wilde had received an email indicating Norwalk High School was planning their Cross Country Invitational for September 25 and wanted to use Veterans Park at Shady Lane. Mr. Boose was okay with this. He told Mr. Welch to double check to make sure there was nothing else going on at the park at that time.
