If Mr. Welch does not receive the 3rd quote for the Courthouse lighting by Friday, he will submit with just the 2 quotes already received. We need to have a contractor before we can order the lights.

The bathrooms on the 2^{nd} floor of administration building are almost done. Will do a walk thru with them to point out items that need to be fixed.



Mr. Welch stated that the law library board was going to re-evaluate the law library project, they did not like the pricing on the doors. There are 4 doors, each with different measurements, so will need to be custom made. The electrical panel door ordered was wrong, so reordered. Mr. Brady suggested having David Price Metals make it if they could not find one to fit.

Mr. Brady asked Mr. Welch how soon did he think we could move on the carpeting at JFS. Mr. Welch told him that it would have to go out to bid; he thought this would be a good question for Garmann Miller as to how to bid this and could you tie in the auditor's floor. Mr. Welch said that the hardest thing about doing the carpet/painting jobs is that the offices want to stay open. We then have to pay more on the jobs if they are working nights and weekends. Mr. Welch felt that the department heads should figure out how to stay open while the work is being done. Mr. Welch said that Ms. Minor has a plan in place.

At 9:30 a.m. Garmann Miller, Chris Monnin, PE Principal/COO and Jim Turissini, AIA.

Discussed Assessment and Budgeting for County Buildings and current buildings.







Mr. Brady asked Mr. Turissini about his thoughts on the 2 carpeting projects that he and Mr. Welch just talked about. Mr. Turissini said it depends on the needs for each location. If the type of carpeting was similar and the job timing was close, then yes, it's plausible. Carpet squares can be an option, but the proper solvent needs to be used so you don't get gases that cause people to get headaches. Getting materials could also be an issue. Mr. Turissini said that, yes, there were some economies of scale by combining the bids.

Mr. Brady asked Mr. Turissini about his proposal range of \$28,000.00 to \$48,000.00 in the assessment bids. If we go to \$48,000.00, what do we get.

Mr. Turissini told him we have a number of buildings and they vary in what needs to be assessed. There are 2 types of assessments: the first type is a warm, safe, dry- walk through or drive by of premises and note that the carpeting is shot and will need to be replaced, etc. A team is sent out with architects, engineers, designers, flooring for the second type of assessment. They nitpick at everything. Look at materials that have been used, equipment aging, capacity, energy conservation, lighting, etc. The second type is what they will be doing here.

The county courthouse scope was originally limited to a partial assessment. Looking at mosaic floors and select plumbing. Typically, when they go through a courthouse, they look at everything because all of the systems are interconnected.

Mr. Turissini said that based on the scope of work listed on the proposal, the courthouse partially doing, partial assessment on 12 and 22 E Main St. office buildings, Norwalk Arts Center- full assessment, but it is an open building, so should not be difficult to assess. Administration building, full assessment and Senior Enrichment Services group of buildings, partial assessments on some buildings, engineering on some, if you demo some of the buildings, the services may be coming from them, so would have to figure that out.

If you do a full assessment on the county courthouse and the administration building, that is when it will end up costing the \$48,000.00.

They end up with a road map for the commissioners to go forward. It fits into several buckets of requirements. Code issues which are things you have to deal with legally. Normally year 1 or 2, some can be pushed out a little further if they are part of another project. 5-year program is next, things that are needed operationally which you need to plan for and provide funding. Last is further that 5 years out, things that would aid the county in future development. Example would be a boiler that may need to be replaced in 15 years.

Mr. Brady asked about what might be included in a full assessment of the courthouse. Electrical, plumbing and floor were included in the partial assessment. A full Assessment would add HVAC, roof (if it had not already been done). Mr. Brady asked if outside lighting could be included and was told yes. Mr. Turissini also mentioned they would have their people look at the outside of the building to make sure that there were no areas of water infiltration. Mr. Brady then mentioned that we had discussed painting outside trim and possibly caulking. He asked if these would be included in a full assessment. Mr. Turissini told him yes, they had 23 points that they look at. Items looked at include roof, structural issues, exterior façade, but are only a few of the points.

The assessment of the courthouse and the administration buildings will be a lot more intensive. These buildings have a lot of hidden items.

Mr. Brady talked about some of the building issues that are not mentioned on the initial proposal, such as, separating the old jail building from the courthouse. Since we are currently looking at building a new building for the Senior Enrichment Center, we will no longer need a full assessment of the Shady Lane complex. Just specifics to demo some or all the buildings.

Mr. Turissini told the commissioners they begin an assessment by meeting with us to prioritize the items needed most. He said they contract for a pod of hours. The commissioners can spend those hours on whatever they want and if they don't spend them all, we won't be charged for them.

Mr. Turissini had the opinion that the 2 buildings he had marked for full assessments were the most important. He told the commissioners that when his people get into a building they may say there is very little to assess. These are the things that should be replaced, very little assessment is required. Prioritize what the commissioners are looking for in the future and where you want to spend your dollars.

Mr. Turissini said when they come out here for the assessments, they would like to get most of the facilities done in 1 or 2 long days. The commissioners will get many reports from the assessment. These will be used to come up with a plan for implementation, based on what the commissioners tell Garmann Miller that their budget/finances can absorb. Will look at needs — wants - requires.

Mr. Brady told him that we have some ARPA funds and some of the findings from the assessment may help us determine how to best use the funds. Mr. Wilde stated that we had hired a consultant to help us determine how the ARPA funds can be used; and feels that this is an opportunity to make upgrades with one-time money. This money is not sustainable. Mr. Wilde is big on LED light bulbs and believes they can help with lighting maintenance, by not having to switch out bulbs as frequently and should save on electricity. Mr. Wilde would like to do things now to help in the future.

Chris Monnin- mechanical engineer

Full assessment – timeframe – may walkthrough and report early June.

Goal to save county money over time.

Mr. Wilde asked if they had heard of SAFEbuilt to see if they had an opinion. They had not heard of them, but will ask around.

Mr. Welch asked them about the administration building elevator. He told them that we had received a quote of about \$300,000.00 a few years back and wanted to know if that number was way off now. Mr. Turissini said that they had done an elevator not to long ago in Mercer County and had estimated \$400,000.00, but the low bid was \$344,000.00. Davis and Newcomer Elevator Company got the low bid.

Mr. Welch asked about the TIPS Program. The program is supposed to give minimum pricing for materials. Mr. Turissini told us that there was a program near them that was similar to the TIPS Program called State firm pricing. He believed this pricing was slightly higher. Others in his area feel that the public bidding process is the best way to make sure you are getting the best price and getting the best for the taxpayer's money. Mr. Wilde told them that we had a vendor that was pushing the TIPS Program. Roofing contractors and water pad companies tend to push the TIPS Program.

Mr. Welch asked if they had ever worked with a design/build contractor called Midstate out of Marion, Ohio. The commissioners have been looking at them for the courthouse floor. Mr. Turissini told him that with a design build firm, you would hire an architect to do a preliminary plan and specs, then the design builder takes over. They hire another architect to move forward. It is not appropriate in Ohio for the same entity to do design and construction. Mr. Turissini said that they could self-perform. Midstate has self-performed for several projects including Wyandot's roof and Logan County Courthouse. Mr. Wilde stated that they make all of their own parts.

Mr. Turissini said they have 2 options; they can design build or be a subcontractor and self-perform. He felt that Midstate had a nice shop.

Mr. Brady stated that he was not a fan of design/build in the public realm because you have to hire an architect to develop and get a price, then you turn over to a design/build, who then has a staff architect or hires another architect.

Mr. Turissini told them that one of the things they would do in the assessment is tell us what delivery methods are most appropriate for various places. Some projects do better with design/build, some do better with construction management at risk (which is bidding out packages), others are hard bid jobs, these are the majority. Garmann Miller has a matrix on size of jobs. Design/build is designed to get jobs done quicker. If you have a schedule to meet it is quicker.

Mr. Welch asked about getting the courthouse floor done. Will look at this during assessment, then figure out what is the best option. Mr. Welch asked if the commissioners were going to approve the proposal for the assessment on Tuesday, March 22, 2022.
