

Mr. Brady said he understood that, but it was still part of salaries and they were not moving it to something totally different. Mr. Brady was hoping by having more road deputies, we could cut down on overtime. They have hired quite a few deputies, but have also lost quite a few deputies. They are still not fully staffed.

Mr. Brady said the question he really wanted to ask about is the moving from PERS to Supplies for gasoline. Mr. Brady noted that the commissioners had said because the gasoline situation was an unknown, when we got to the end of the year, we would be willing to put additional money in for gasoline. Mr. Brady thought that moving money from PERS to fuel is like they are moving it from benefits to supplies and wondered why there was so much money left in PERS.

TUESDAY

Mr. Boose said it is because they did not hire those people at the beginning of the year, therefore, since it took time to get the employees hired, not all the money was spent. Mr. Brady stated that we had told them we would cover the additional costs of gasoline. Mr. Boose said that the bigger question is why is Medicare short and thought it was an easy calculation. Mr. Brady hoped they had planned their budget for next year correctly.

Mr. Boose stated that the interim budget for this year is down from last years interim budget by \$.5M and felt that some management is needed to be done to keep gasoline costs as low as possible. Mr. Boose would like to see the Sheriff's policies for next year to keep gasoline costs down.

OLD BUSINESS / NEW BUSINESS

<u>Administrator/Clerk updates:</u>

- Ms. Ziemba reminded Mr. Boose he wanted to discuss fuel for the jail. Mr. Strickler explained it was for transports to the courthouse, juvenile detention and that type of place.
- Sheriff requested more money for gasoline and they wanted to take money out of the natural gas line and move it to the supplies line for gasoline. Mr. Boose explained the money in those accounts came from the Commissioners, who pay the utility bills. Mr. Boose said you never know what the utility bills are going to do, so you have to make sure you have enough money in those accounts to cover the bills.
- This year is unique because of the price of gasoline. Mr. Boose's concern if we take money out of that line, then 3 years down the road it comes up again and they say we did it 3 years ago. There may be different commissioners in office and the precedent could be if there is extra money in there, let's use it. We are setting a horrible precedent if we do that.
- Mr. Boose looked at the accounts the sheriff controls and there are three different account's which have money in them and could be used for this transfer. Mr. Boose would like to email recommendations to the Sheriff/Jail.
 - Unemployment line We have needed very little money for this line and Mr. Boose can't see any reason for needing unemployment for the rest of the year. There is \$4,663.71 in that account.
 - \circ Hospitalization has 21% of the money in there. This could be used also.
 - Medical hygiene There is currently \$152,167.00 left in that account. So far this year we have spent \$245,709.00 for the first 10 months. That is approximately \$25,000.00 a month, so we would only need about \$50,000.00 more in that account for the rest of the year. Leaving an extra \$100,000 in that account.
- Mr. Boose said that we agreed to look at gasoline charges for the rest of year and felt if they looked at the three accounts he mentioned, they would be a better place to take the money from than the Natural Gas account.
- Mr. Boose reminded the other commissioners that when looking at some of the reports next year, if you look at natural gas and we transfer it out, it looks like we spent more money on gas than we did. Then if we have a problem with gas next year and we go back to look, they would say it is the same as last year.
- Mr. Boose also wants to challenge the sheriff's office to manage what we give him in interim and final budget. We have to deal with the price of gasoline. Mr. Boose would hope, knowing this, that they change some policies to keep it down or spend less in other line items. Mr. Brady supports Mr. Boose's idea of sending them recommendations.
- Mr. Wilde stated that we had promised them the gasoline and the budget has money in it, so pick a fund that has excess to move it from. Mr. Boose stressed that there are still ways to manage the budget. Mr. Wilde asked if the money which is not used will roll over. Mr. Boose replied yes, but kind of. Jail money would roll back into the jail, not the general fund.
- Transportation Ms. Ziemba has received three applications for the Transit Director job. Mr. Boose asked if there was a plan to move forward. Ms. Ziemba said that was a question for Ms. Hozalski and Transit 9-1-1 and did not think there was a date set. Mr. Brady felt they should try to move forward. Mr. Boose explained he wanted to move forward because if he was sending in his application for a job, he wouldn't expect it to be looked at a month or 2 later. The longer you wait, the less chance you have of the person still being available. Ms. Ziemba will check if there are any more applications, then move forward.
- Mr. Boose also wanted to move forward the with EMA position. He understood they were redoing the job description, but he was afraid if they put it aside, it could be a long time before they get to it. Ms. Ziemba stated she will make sure Ms. Hozalski is working on it.
- SAFEbuilt Mr. Wilde explained to Mr. Strickler that Ms. Ziemba needed a copy of the final agreement. They also needed to get the fee schedule to her. Mr. Wilde asked Mr. Boose if he wanted them to wait, since Mr. Boose would be gone next week.
- Mr. Strickler asked if we had heard back from Richland County Building Department after we sent the letter cancelling our contract with them. No one had heard anything.
- SAFEbuilt called to let us know they are bringing on Seneca and Wyandot counties. They asked if we needed anything.
- Mr. Strickler asked if they would be getting more inspectors since they will be covering more areas. Mr. Wilde said they told him they can pull inspectors from other areas if needed. Mr. Boose thought we should bring this concern up with them. Mr. Strickler said his concern with this is; why do we want to change if we will have the same issues as we did with Richland County. Mr. Wilde said he would be talking with them today and will voice this concern. Mr. Wilde was going to get everything to Ms. Ziemba and hoped we would have everything needed for next Tuesday.
- Mr. Boose wanted to add something else. Ms. Ziemba had given an updated budget. As of right now

it balances with the budget commission's amount. That doesn't mean changes can't be made and we probably won't pass it until right before Winter Conference. There is still plenty of time to look at it. Mr. Boose is still looking at several accounts.

- 099/Transfer Out account one year ago it was at \$3,886,000.00 and for the interim budget this year it is at \$2,250,000.00, which is \$1.5M less. All Commissioner accounts need to be looked at. Mr. Boose hopes we have an opportunity to look at these more in the final budget and wanted to point out that we are already down by \$1.5M in that account. There will not be a lot of extra money in the final budget unless we get a huge carryover that will allow us to increase the interim budget. The interim budget has no increases for contracts or raises. Mr. Boose said that is where we do all of our capital projects.
- Mr. Boose said we have a long-term plan for our capital projects and he has asked Mr. Welch to bring it in so they could update it. Ms. Ziemba asked Mr. Wilde and Mr. Brady to review the budget that she and Mr. Boose worked on and let her know if there is anything they see as an issue or would like to have changed. Mr. Boose said they had a significant amount which had changed or was not included in the previous interim budget. There was over \$3M in items they put in the interim budget.
- Mr. Strickler asked about raises and asked if they were going to give the county employees raises in the interim budget like last year and Mr. Boose told him no.

At 10:00 a.m. Josh Jasinski, Dog Warden – Cost Analysis Public Hearing.

Mr. Jasinski stated the hearing for the cost analysis of the Dog Warden's Office is to determine how the fees match up to the actual costs.

Ms. Ziemba asked Mr. Jasinski to state the current costs and where he thought the fees should go.

Mr. Wilde stated the item descriptions and Mr. Jasinski said the costs and proposed new fees

Mr. Wilde asked if anyone wanted to speak for the hearing, hearing none, Mr. Wilde called a second time for anyone to speak in favor, hearing none, Mr. Wilde called a third time for anyone to speak in favor.

Mr. Boose wanted to comment that these were very minor increases compared to the costs, which have gone up since 2004 and he would recommend that we adopt the increases when it comes time to do it. Mr. Boose thanked Mr. Jasinski and all of his staff for all the work they put into this. Mr. Boose thought this helps them to get a better understanding of what the costs are and sometimes it really surprises you when going from \$1.62 a gallon to \$3.60 a gallon. Mr. Brady said that when he saw the numbers he was amazed at how low they still were.

Mr. Wilde called for testimony against, hearing none called twice, hearing none called thrice. Hearing none, *Mr.* Wilde closed the public hearing.

At 10:06 a.m. Mr. Wilde adjourned the hearing

Ms. Ziemba noted that she would prepare a resolution to adopt these fees and should have it for Thursday's meeting. Ms. Ziemba said the new fees would take effect on January 01, 2023.

Mr. Brady asked how it was going with the adoptions at Mr. Jasinski's office. Mr. Jasinski told him it depends on the time of the year. It also moves with the economy. If prices are up, adoptions go down a little. They have about 5 right now, but they get a lot of people calling to release their dogs to them. Mr. Jasinski said that is not their job, but they try to help if they can. A lot them get out right away. Mr. Brady asked if people were looking for specific breeds. Mr. Jasinski did not think so. Mr. Boose thought people might want a pure breed dog more than a mixed breed. Mr. Jasinski said they had been doing a drawing to decide who would get a dog, but it was controversial, so they went to taking applications. They determine who is the best fit for a dog and they have the right to refuse an adoption.

Mr. Wilde noted that in 2021 they had 205 dogs claimed and 162 dogs adopted. They also had 13 EBI (Euthanasia by Injection).

Mr. Boose said that Franklin County has just passed a new policy that unless it is a service animal, no more dogs can be brought in to public offices because they had so many that people would use the dog kennels dogs to get people to come to their offices and were having to clean offices more because of the dogs.

Assistant Prosecutor updates: – none

Commissioner Brady updates:

- Mr. Brady did not attend Friends of Mercy, but did make it to the Township Association meeting on Thursday night.
- South Benedict corridor meeting yesterday. They are looking at ways to beautify that section coming in to Norwalk. The area is predominately in Norwalk, but the intersection of Benedict and S. Norwalk Road is in the county. It is very difficult to get across this intersection. They discussed the different options and acquiring the property if needed.
- Mr. Boose suggested if someone brings up wanting a traffic signal that Mr. Brady ask those people what if it is something other than a light? Would you feel the same way? Mr. Boose doesn't want people to think a traffic light is their only option. Mr. Brady said that even though it is not within the city limits, Norwalk is willing to work with the county and ODOT. Mr. Boose thought that S. Norwalk Road /Benedict Ave. intersection was in the city limits.
- Mr. Brady said it was interesting the way they sloped the bridge, it is hard to see traffic.

Commissioner Boose updates:

- Workforce Development meeting. Mr. Boose discussed businesses trying different work schedules to see what works. Mr. Wilde said they had discussed this at a meeting he attended. Mr. Boose said the businesses can share their experiences with different scheduling options.
- Mr. Boose thought that a local business was opening a new line in January and we were picked over other areas of the state or country because of our ability to get things done. Mr. Boose said we complain about our workforce issues, but it could be worse. It was found that we don't market some things well enough.
- Discussed Goodwill Industries going back to normal hours finally and hiring high school students to cover the 5 to 8 p.m. shift. Goodwill Industries also has a grant to train people 55 years or older on new skills. Currently the grant only allows the people to work at a nonprofit organization or governmental agency. They don't have anyone from Huron County in this program.
- Besides having someone over 55 that would like to do this, you would need to have a place for them to work.
- Mr. Boose noted that Nathan Manning's Office rarely misses a meeting.
