

RE: Request for Courthouse Energy/Historic Structure Funding

Dear Congressman Gillmor:

This letter is a follow-up to our meeting last week in Willard, Ohio, where we had a very brief discussion concerning our request for 1,000,000.00 for our Courthouse. We are sure it was obvious that we were very disappointed with your response – i.e., no funding at this time.

Let us restate the facts that for Huron County this Courthouse is projected to be the place for county legal business for the next 25 years and preliminary plans have been discussed to relocate some of the offices to allow a third judge to also occupy this building. No major renovations have been made to this facility since the 1960's. We are in the process of borrowing funds from the future to pay for the heating and air conditioning work that absolutely must be done to allow the courts to function. Building security is a serious concern and we have discussed the addition of a foyer on the front entrance to allow for reduced heat loss in the winter and cooling in the summer.

We find it hard to think that a project such as Indian Mills would take first priority over a Courthouse that truly needs upgrading. Even the bathrooms are in such bad shape that county residents would rather not use them. A Courthouse should be a model for the community but in reality it just shows how poor a county we really are. You talked about the need for more industry and business in Ohio. The poor economy and high taxes is observed by businesses that are looking to relocate and those points keep good jobs away.

We would ask that you put in writing to us, some thoughts on how you can help us achieve the improvement of this facility that is so sorely needed.
